The establishment was serving breakfast. Cinnamon roll was at 146 degrees, milk was at 39 degrees, pre-package cereal, juice, and fresh fruit was on the menu.

Handwashing sink was at 104 degrees.

Wash sink was at 95 degrees, rinse at 75 degrees, and sanitize at 75 degrees. The sanitize sink was at 200ppm and the sanitize bucket at 150ppm.

Hot holding and cold holding units are within acceptable temperature range.

The refrigerator and freezer are within temperature range.
