Refrigerated, ready-to-eat, potentially hazardous food prepared in the facility, must be marked with date of preparation, if held greater than 24 hours. Food must be stored six inches above the floor.

Violation #25. Ventilation/Storage/Sufficient equipment

Clean vents above 4 compartment sink CODE REFERENCE: Hoods. 64E-11.006(1)(g)-(I). There will be approved hoods over cooking equipment. Proper dispensers for tableware. There will be sufficient spoons, scoops in the food prep and service areas and sufficient utensils. Dipper wells for ice cream. There will be a janitor sink or can wash.

Violation #29. Cleanliness of equipment


