Ensure chemical sanitizer is maintained at recommended concentration according to manufacturers specifications. Observed quaternary ammonia in sanitizer buckets at 100ppm-150ppm during inspection.

CODE REFERENCE: 64E-11.003(2). In-use wiping cloths shall be stored in an effective and approved sanitizing solution between uses.
