<p>Violation #16. Food-contact surfaces; cleaned & sanitized Ensure food-contact surfaces are visibly clean and sanitized. Observed can opener blade with build-up of food debris.</p>
<p>Violation #39. No Contamination (preparation, storage, display) Protect food from all sources of contamination; stored in clean, dry location at least 6 inches above floor. Observed two boxes of chips on ground.</p>
<p>Violation #41. Wiping cloths: properly used & stored Store wiping cloths between uses in chemical sanitizer solution. Observed two wiping cloths on counter.</p>
<p>Violation #49. Non-food contact surfaces clean Maintain all coolers units in a thoroughly clean and sanitized condition. Observed standing water/residue substance at bottom of milk cooler.</p>
