Effective measures shall be taken to control the presence of pests in the food establishment. Unless otherwise approved, live animals shall not be allowed.</p>
<p>Violation #41. Wiping cloths: properly used & stored Sanitizing bucket concentration was at 50ppm, too low for quat. ammonia to be effective. CODE REFERENCE: 64E-11.003(2). In-use wiping cloths shall be stored in an effective and approved sanitizing solution between uses.</p>
<p>Violation #55. Facilities installed, maintained, & clean Sprinkler cover in walk-in freezer appears broken at time of inspection. Sprinkler closest to door. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
