Some pans were put away wet at time of inspection.

CODE REFERENCE: 64E-11.003(4). Utensils and equipment must be cleaned, sanitized and air dried prior to storage. Utensils, equipment, and linens must be properly cleaned and stored.

Violation #55. Facilities installed, maintained, & clean

Walk-in freezer has ice building up in the lower left corner of the doorway. Additionally, floor in dry storage room is worn such that it may no longer be easily cleanable.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
