<p>Violation #36. Thermometers provided & accurate Reach-in coolers missing internal thermometers. Corrected during inspection. CODE REFERENCE: 64E-11.003(4). Thermometers must be calibrated to ensure accuracy in accordance with Rule requirements. Food thermometers scaled in Celsius (C) shall be accurate to plus or minus 1°C or in Fahrenheit (F), accurate to plus or minus 2°F. Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #39. No Contamination (preparation, storage, display) Reach-in freezer has condensation on ceiling. Drips down onto food before pooling at bottom at the time of inspection. CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.</p>
<p>Violation #55. Facilities installed, maintained, & clean Reach-freezer leaking water at time of inspection. Same freezer as mentioned above. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>

Sani sink 200ppm quat ammonia, sani bucket 150 ppm quat ammonia,

Chicken nuggets cooked to 170 hot held 165F, mini corn dogs cooked to 200F, Carrots hot held 140F, burgers hot held 143F, milk cold hold 34F
