Corrected on site. Manager discard them.

General Comments

Recomendations: to keep hot holding temperatures through out serving time, keep food in hot holding units until ready to serve or display a small amount on well. to keep cold holding temperatures throught serving time, keep ice below tray in a separate tray.
Cold holding and hot holding was at approved temperatures.
