Violation #10. Food container
Store all potential hazardous ready to eat foods in a clean, covered, labeled container. Observed sliced cheese not stored covered or labeled during inspection.
CODE REFERENCE: Storage Containers. 64E-11.004(13)(14). Food storage containers shall be clean, covered, and marked with their contents. Refrigerated, ready-to-eat, potentially hazardous food prepared in the facility, must be marked with date of preparation, if held greater than 24 hours. Food must be stored six inches above the floor.

Violation #29. Cleanliness of equipment
Maintain food and storage equipment clean and sanitized. Observed excessive black bio growth in refrigerators and on gaskets during inspection. Counters, drawers and cabinets with lots of debris during inspection.
CODE REFERENCE: Cleaned. 64E-11.006(4). All equipment will be maintained in a clean and sanitized manner.
