This inspection occurred during the COVID-19 school closure. This school is providing prepackaged meals to kids in the community via drive-up. The school itself is closed and the kitchen is not preparing typical hot meals. Instead, they are packaging 5 breakfast and 5 lunch meals to distribute to children. This meal pickup will occur only on Tuesday of each week while school remains closed due to COVID-19.
