<p>Violation #10. Handwashing sinks, accessible & supplies Handwashing sink is not conveniently located for employees at front serving line; Need additional handsink.</p> <p>CODE REFERENCE: 64E-11.003(5)(d). Handwashing sinks are properly equipped with hand soap, individual disposable towels or hand drying device, and signage; and conveniently located.</p>
<p>Violation #22. Cold holding temperatures Cold holding unit at front serving line was observed not working during time of inspection, and lack of cold holding at front serving line is an issue to try and keep foods at proper temperature. Salads, hard boiled eggs, and ranch dressing observed out of temp.</p> <p>CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.</p>
<p>Violation #47. Food & non-food contact surfaces Cold holding unit at front line and glass door refrigerator not working properly; Must maintain 41F or below; Repair or Replace. Washer for laundry is rusty; Replace.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
<p>Violation #56. Ventilation & lighting Observed lights in walk in freezer not working; Repair.</p> <p>CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.</p>
