Salad boxes cold held in a bin over ice. Not held at 41F.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.

Violation #55. Facilities installed, maintained, & clean

Walk-in freezer door does not seal easily when closed. Ice and moisture build-up in freezer as a result.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
