Violations Comments

Violation #10. Handwashing sinks, accessible & supplies
Kitchen only has 1 handsink near back prep sink area, and it had no hot water; turned a knob and then it had hot water, but would not shut off completely-Repair and hot water must be on at all times.
Handsink is needed somewhere near serving line for better accessibility.
CODE REFERENCE: 64E-11.003(5)(d). Handwashing sinks are properly equipped with hand soap, individual disposable towels or hand drying device, and signage; and conveniently located.

Violation #22. Cold holding temperatures
Salads and eggs on line not cold held at proper temperature of 41F or below. Eggs placed near hot well and salads have too many barriers between cold surface to maintain proper temperature.
Work on methods to improve cold holding.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.
