<p>Violation #22. Cold holding temperatures Salad display units-Two of the three units did not feel cold to the touch and thermometer provided inside was reading 58F-60F. Salad temps-48F or above. cantaloupe (cut) 47F. Must maintain all cold foods at 41F or below. Yogurt meals cold holding on line are too high above cold unit to maintain proper temperature.</p> <p>CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.</p>
<p>Violation #36. Thermometers provided & accurate One thermometer missing in reach in refrigerator near center of front line. One thermometer in open glass display case by register does not appear to be accurate; Replace. (Repeat) Need to check all refrigerators and freezers for accurate thermometers; Place inside near warmest point of unit. Some outside digital thermometers not accurate on units.</p> <p>CODE REFERENCE: 64E-11.003(4). Thermometers must be calibrated to ensure accuracy in accordance with Rule requirements. Food thermometers scaled in Celsius (C) shall be accurate to plus or minus 1°C or in Fahrenheit (F), accurate to plus or minus 2°F. Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #47. Food & non-food contact surfaces Repair salad display cases to maintain 41F or below. Replace torn gaskets on 2-door reach in freezer in kitchen. Replace warmer unit bulbs that are not working.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
