Commercial hot holding unit is needed to maintain proper temperatures. Use of commercial crock pots or cheese warmer unit recommended.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
