Several bags of mac-n-cheese sitting out on pan at room temperature (76F-78F). Must thaw all foods under refrigeration and maintain 41F or below until cook process takes place or thaw during cook process.

Keep working on cold holding methods between prep to the line for service. Try to avoid placing cold items next to hotwell on serving line.

Notes: milk cooler milk 40F; line HH mac-n-cheese 139F, peas 138F; Warmer unit mac-n-cheese 168F; milk & cheese 36F WIC; refrig salads 40F; WIC & WIF OK. Sanitizer 200ppm.
