<p>Violation #47. Food & non-food contact surfaces Ensure that all utensils are composed of approved materials. Observed wooden handle on spatula. Discarded. Corrected on Site. CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
<p>Violation #55. Facilities installed, maintained, & clean Air curtain only activates when left side of double doors open. Should turn on in response to either or both doors opening. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
