Violation #21. Hot holding temperatures

Baked beans held at serving line temped 122F. Returned to hot holder and raised to 137F.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

General Comments

Inspection occurred during lunch service.

Two sinks furthest from office did not reach 100F water temp during inspection. Facility is aware of issue and has taken steps to correct.

Notes; sani sink 250ppm quat. ammonia, buckets 200-250ppm quat ammonia, juice cold hold 39F in walk-in cooler, cooked chicken chilled for salad in walk-in cooler at 40F, hot hold beans in hot holding unit 137-142F, burgers cooked to 166F, hot hold beans at line 122F returned to hot holding unit.
