Chicken nuggets hot holding in serving line measure 122F at time of inspection. Returned to oven and later measured 139-140F.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Inspection took place during last lunch service.

temperatures taken; chicken nuggets hot holding 122 and then 140F in serving line and 145 in hot holder. sweet potato fries 137.9 F, melon held at 40F in cold holding RIC, milk in WIC 37F.

sanitizing sink quat ammonia concentration 250ppm, lettuce cooling from ambient temps in WIC at 51F
