Provide soap to handwash sink and ensure it is accessible at all times. Observed no soap at handwash sink and cart blocking sink. Corrected on site.

Violation #19. Reheating procedures for hot holding

Ensure ready-to-eat (RTE) food taken from commercially processed, hermetically sealed containers must be reheated to 135F within two (2) hours for hot holding. Crockpots cannot be used to rapidly reheat for hot holding. Observed nachos cheese reheating in crockpot.
