FMC Elizabeth Huffman expires 5-2026. Notes, 2 HWS, 3 compartment, test strips, WIC at 35 degrees, freezer at -8. RIC at 39 degrees. Hot holding sauce at 146 degrees, pasta at 154. Mop sink is okay, dumpster is okay. Make sure sanitizer buckets have proper sanitizer level in them, observed at 100ppm. Thank you.
