Notes FMC certification Lisa Nyman expires 9-2027. Hot holding mozzarella cheese at 150. Fries at 125. Put back in the warmer unit until corrected, now at 138. HWS at 110 degrees. Quat ammonium at 200ppm. Dumpsters are okay. Mop sink okay. Thank you.
