Notes 3 HWS, 3 compartment sink, WIC at 39 degrees. Hot holding pasta at 151, sauce at 154 degrees. Sanitizer at 200ppm. Make sure sanitizer buckets have proper level of sanitizer in them. FMC Erica Garcia expires 2-2028. Mop sink okay, Dumpsters are okay. Thank you.
